

## Announcement of Valaya Alongkorn Rajabhat University under the Royal Patronage Subject: No Gift Policy on all Occasions, Festivals and Special Occasions Fiscal Year B.E. 2567 (2024)

In accordance with the Organic Act on Prevention and Suppression of Corruption, B.E. 2561 (2018), Section 128, which stated that public officials are prohibited from accepting assets or any other benefits which may be calculated in monetary value from any person, except for the assets or benefit which may entitled to such persons under the laws, regulations, or rules permitted by virtue of law, and according to the Cabinet resolution on the 8<sup>th</sup> December, B.E. 2563 (2020), the country's reform plan on prevention and suppression of corruption and misconduct was approved, assigning to carry out important reform activities (Big Rock) which noted in the 1<sup>st</sup> goal, item 1.1, that "all government agencies shall declare themselves as the agencies that all government officials do not accept gifts and gifts of any kind from performing their duties (No Gift Policy)".

In this regard, to declare intention on anti-corruption and all kinds of misconducts in order to promote virtue, morality, and create value in the performance of duties, including creating organizational cultures and transparency, Valaya Alongkorn Rajabhat University under the Royal Patronage established the policy to ensure that all executives, university officials, university employees, and employees working for Valaya Alongkorn Rajabhat University under the Royal Patronage must not accept any forms of monetary gift from performing duties. Valaya Alongkorn Rajabhat University under the Royal Patronage hereby issues the university policy as follows:

- 1. All executives, university officials, university employees, and employees working for Valaya Alongkorn Rajabhat University under the Royal Patronage must not accept or offer any forms of monetary gift related to performing duties from any persons to be engaged in procurement of the university's processes.
- 2. All executives, university officials, university employees, and employees working for Valaya Alongkorn Rajabhat University under the Royal Patronage must not illegally seek a gift, souvenir or any other form of benefits from others.
- 3. Sending well wishes on special occasions may only be provided in the form of greeting cards, sympathy cards, verbal wishes, or wishes via social media instead of materials.

Unless it is unavoidable, ones must comply with the rules for accepting gifts or prizes and any other benefits according to the Notification of the National Anti-Corruption Commission Re: Rules for Receiving Assets or Other Benefits, by the Code of Conduct of State Officials B.E. 2563 (2020).

Therefore, it is announced for the general information, and the executives, university officials, university employees, and employees working for the university shall strictly adhere to the policy.
